*Up to twelve JUNIORS from Adair County, Casey County, Clinton County, Lincoln County, McCreary County, Pulaski County, Somerset Christian, Somerset, Southwestern, Russell County, and Wayne County High Schools, as well as one applicant from private schools' and home-school programs, will win an ALL-EXPENSE-PAID trip to Washington, D. C.*

**A**pplications for the 2019 Rural Electric Youth Tour in Washington, D. C., are now being accepted by South Kentucky Rural Electric Cooperative. Competition for the all-expense-paid trip is open to high school juniors, between the ages of 16 and 18, whose parent(s) or guardian(s) receive electric service at their primary residence from South Kentucky RECC. Children or grandchildren of South Kentucky RECC employees, directors, and attorneys are not eligible.

Students must complete a typed essay of 500 words on the subject "Why I want to represent South Kentucky RECC in Washington, D. C." All essays and a completed application form must be returned to the guidance counselor of each school or South Kentucky RECC Member Service Centers by the end of the work day on **January 25, 2019**.

**Essay Rules:**

- Essays must have a cover sheet with title, student's name and student's school
- Essays must have student's name and school at the top of each page
- Essays should be written in APA format

Finally, we encourage students to have an English teacher review your work before submission.

Twenty-four semifinalists from Adair County High School, Casey County High School, Clinton County High School, Lincoln County High School, McCreary Central High School, Pulaski County High School, Somerset Christian School, Somerset High School, Southwestern High School, Russell County High School, and Wayne County High School, and representatives from private schools and the home school program will be selected for a one-day trip to Frankfort, Kentucky, on March 5, for the Frankfort Rural Electric Youth Tour. From that group, up to 12 will be chosen to go to Washington, D. C. for the Rural Electric Youth Tour, June 14-21, where they will tour national landmarks and learn more about how the United States government works.
